PARKING AGREEMENT

The Permittee and the Washington Park Parking Lot Committee ("WPPLC"), agree as follows with respect to Permittee's passenger vehicle parked at the Washington Park Parking Lot:

- 1) Parking space is available only during the hours of **6:00 AM to 6:00 PM, Monday through Friday**.
- 2) Permittee shall have a revocable license to park his/her vehicle at the above location, and no bailment is created. Parking shall be granted on a non-reserved stall basis, but WPPLC shall have the right to specify the parking space to be used. WPPLC does not guarantee that parking space will be available at all times for use by Permittee.
- 3) PERMITTEE ASSUMES THE RISK OF ANY LOSS OR DAMAGE TO THE VEHICLE OR PERSONAL PROPERTY LEFT THEREIN INCLUDING BUT NOT LIMITED TO DAMAGE CAUSED BY FIRE, THEFT, FORCE MAJEURE, ACTS OF ANY THIRD PARTIES OR ANY OTHER CAUSES. IN NO EVENT WILL WPPLC BE LIABLE FOR AND PERMITTEE HEREBY WAIVES ALL CLAIMS AGAINST WPPLC FOR PERMITTEE'S CONSEQUENTIAL DAMAGES, LOSS OF INCOME OR PROFITS OR LOSS OF USE OF THE VEHICLE.
- 4) Permittee shall indemnify, defend and hold WPPLC harmless from liability for damages or injuries caused by the negligence or misconduct of Permittee including faulty brakes or any other defect in the vehicle, or by the failure of Permittee to properly set a vehicle's brakes.
- 5) Permittee agrees to pay WPPLC \$35.00 per month / \$100 per season / \$10 per day for parking space. No deductions or allowances from the monthly charge will be made for days the Permittee does not use the parking facilities. For accounting purposes, the monthly period shall be the calendar month.
- 6) The current monthly parking identification tag (one tag per space rented) supplied by WPPLC must be displayed in view on the vehicle at all times while on the parking location or Permittee will be subject to a citation under city ordinance.
- 7) Permittee agrees to be bound by such rules and regulations as WPPLC may, from time to time, post at the parking location.
- 8) If Permittee fails to comply with any of the terms and conditions of this agreement, WPPLC shall have the right to immediately terminate this agreement without prior notice to Permittee, and WPPLC will have available to it all other remedies available at law or in equity.

Permittee has read the above contract. Permittee agrees that Permittee's vehicle is parked subject to the provisions of this Parking Agreement.
